ENROLLMENT AGREEMENT

Applying for Grade _____

Academic Year 2009 - 2010

I. General Conditions

We, the undersigned Parents or legal guardians, agree to the conditions outlined in this Enrollment Agreement and hereby enroll _____ as a student at Fuqua School (the School) for the academic year beginning (denote month and year) _____. We understand that this Enrollment Agreement is between the Parents or legal guardians of the above-named student and Fuqua School. It is not binding on the School until signed by the President or his/her authorized designee. The School reserves the right to accept or reject students for enrollment for any reason, notwithstanding the submission of the Agreement. This agreement confirms the commitment of the Parents to pay tuition to the School in return for its reserving a place for the student and providing educational services. In the event that the School is unable to provide or continue its educational services to the student for any cause, the School shall not be liable for claims for any costs or expenses incurred as a result.

We agree to pay all tuition and related fees according to one of the payment plans detailed in this Agreement and agree to pay a 1.5% late charge per month on past due balances. We understand that a **non-refundable** registration fee of **\$350** is required with this Enrollment Agreement to hold space for the student. This fee is in addition to the stated tuition charge for the academic year if we are a first-time applicant or a re-applicant missing the April 1 deadline. We also understand that if payment arrangements have not been made prior to the first day of school or if the terms for the selected payment option are not met, the above-named student will not be permitted to attend classes.

We acknowledge that the School, to continue meeting operating expenses and to continue maintaining plant facilities, must be assured, in advance, of required annual income from tuition. We understand that the above-named student is therefore enrolled for the entire academic year, unless written notice of cancellation reaches the School on or before July 1. We understand that in the event of the student's withdrawal or dismissal, we remain obligated to pay all tuition and fees for each semester in which the student is enrolled. Financial assistance, multi-child discounts, and other discounting will be rendered null and void and will not be credited to the student's account in the event of withdrawal or dismissal. Each of us realizes that we are individually responsible for the total amounts due under this enrollment agreement.

II. Financial Arrangements

III. Regulations, Conduct, and Records

We recognize that the School reserves the right to dismiss any student (without a tuition reduction or remission) in the event he/she or members of his/her family engage in conduct that Fuqua School considers to be detrimental to the learning environment or reputation of the School, that fails to support the School's policies or regulations, or that prevents the School from fulfilling its mission. Dismissal may occur at any point in the school year. We understand that the basis for dismissal can include, but is not limited to, a violation of the Student Honor Code or the Student Behavioral Guidelines, failure to maintain acceptable academic standards as outlined in school policy, or a single off-campus act.

We agree to be bound by the conditions of enrollment expressed in this Agreement and to support the School in the administration of school policies and in the enforcement of all student regulations. We authorize the School to release the above-named student's academic transcript to any college or university to which he/she may apply for admission. We understand that the School may withhold the official transcripts and/or records of any student until written notification of the student's withdrawal has been received from the parent/guardian and all financial matters related to the student's enrollment have been cleared.

This contract will be governed by the laws of the Commonwealth of Virginia. Any and all litigation concerning this contract including, but not limited to, non-payment of fees, shall be brought in the general district or circuit court of Prince Edward County, Virginia. The undersigned agrees to pay reasonable costs for collection of past due accounts, including attorney's fees.

We understand that each provision of this Agreement is severable and independent, and will remain in full force and effect, without regard to the ability to enforce any other provision(s) herein. In executing this Agreement, we certify that the statements made are true and correct, that we are authorized to execute this Agreement on our behalf and on the behalf of all others having a parental relationship to the student, and that we agree to be bound by the terms of this Agreement, a copy of which has been provided us by the school.
